This application was received by the PC after the publication of the agenda for this meeting. It would, however, be beyond the consultation period by the next meeting of the PC and discussion was permitted.

Cllr Kyle Blue declared an interest in this item on the grounds that his firm is

involved with the application and withdrew from the discussion.

It was generally agreed that the existing land holding attached to this house was too small for it ever to be viable as an agricultural enterprise. The requirement for an agricultural tenancy at this location was therefore

considered to be redundant.

It was recommended that the S106 condition be removed.

#### **Jubilee Bonfire**

A letter from Crosby Ravensworth PC in appreciation of Jubilee Bonfire organisation on Beacon Hill was read out. A substantial number of people from both parishes had enjoyed this major event.

# **Wind Turbines**

A letter received from a resident asking Parish Council's policy on small wind turbine installations. Particular note was made of the intrusive appearance of one at Moor House Farm, Orton. It was noted that the parish council, when considering this application, had recommended that the unit should be dark coloured to blend with the background trees. (Minutes January 2011, Application No. 10/0700).

# **Public Participation**

Cllr Peter Thornton introduced information on the new formula for the funding of Cumbria's schools. There is no additional funding, just a revised system of distribution in which there would be winners and losers.

Small village primary schools such as Orton & Ravenstonedale were likely to benefit from the new scheme.

There was some discussion about the location of speed indicator signs which are due to be installed on the approach roads from Tebay and Appleby. It was suggested that the Appleby sign should be further out of the village than the site proposed. Peter Thornton volunteered to negotiate the site with County Highways. It was agreed that, if re-location was not an option, the existing site would be better than nothing.

Orton Manor Court had, at its September meeting, resumed its contention that the former Liberal Club should be made available for community use. The parish council had, at its meeting in November 2011, concluded that "although Orton Liberal Club is a significant building within the village, the Parish Council has no jurisdiction over it". Mary Jenkin volunteered to try to establish whether there are any surviving relatives of the original donor who may have a claim on the property.
