A presentation by Carolyn Greenhalgh and Kevan Guest outlined the work and facilities offered by this local one-stop-shop which aims to support independent living in one's own home.

Question Time

Around sixty people attended a lively Question Time event held in Orton Market Hall on Thursday 12th March 12, 2015 to discuss Reduced Rural Services, including buses.

The panel, comprising Libby Bateman, a Conservative councillor representing Kirkby Stephen on Cumbria County Council; Adrian Todd, a Conservative councillor on Eden Council representing Orton and Tebay; Ian Torkington, the Liberal Democrat councillor for Ravenstonedale on Eden, and Lib Dem Peter Thornton, the leader of South Lakeland District Council plus the Rev. Phil Dew, the Methodist minister for Kirkby Stephen

The organisers had gathered questions from other WIs, businesses, young people and members of the public.

Orton Street Lighting

Menna Lewis and Mary Jenkin had surveyed the existing footway lights with Chris Slater and other members of EDC, on 5th March 2015 to review EDC's current proposals for the future reduction in the number of units maintained.

Particular concern was expressed about the light on the footpath opposite the school where there is a bridge across the beck which is regularly used as a route to and from school. This posed particular problems as that footpath in not a designated highway, merely a "permissive footpath" on private property. The legal position is to be investigated.
