Orton CE School

Representatives of Orton CE School outlined a proposal which they are considering for an additional, stand-alone classroom to provide additional space for increasing pupil numbers. The proposed self-contained unit would also be able provide accommodation for Adult Learning, evening classes etc. since withdrawal of public transport from the village. Suggestions were invited for potential facilities currently lacking in the village.

Footway Lighting

Notification had been received that a new lighting standard would be erected at Brookside by the end of July. This should have read "Beckside".

The light opposite Brook View is still under consideration by EDC but is unlikely to be replaced. Alternative arrangements are being sought by councillors.
