A verbal request had been received from Orton Manor Court (OMC) that the parish council should arrange for the resurfacing of the permissive footpath opposite Orton school with OMC contributing half the cost.

The footpath is on Manor Court land and is therefore the responsibility of that body. It had been suggested that the parish council would be able to reduce the cost by reclaiming the VAT element. The Clerk advised that this was not the case as the proposal would not meet the legal criteria.

The Clerk advised that, since four of the six members present were also members of the OMC management committee, they should have declared a conflict of interests and were not eligible to take part in any decision on this matter (Localism Act 2011).. The remaining two councillors did not constitute a legal quorum of the parish council to make a decision.

The matter was to be referred to the Manor Court for action.
